Introduction

The SEN and Disability Act 2001 extended the Disability Discrimination Act 1995 (DDA) to cover education. Since September 2002, the Governing Body has had three key duties towards disabled pupils, under Part 4 of the DDA:

- not to treat disabled pupils less favourably for a reason related to their disability;
- · to make reasonable adjustments for disabled pupils, so that they are not at a substantial disadvantage;
- to plan to increase access to education for disabled pupils.

This plan sets out the proposals of the Governing Body of the school to increase access to education for disabled pupils in the three areas required by the planning duties in the DDA:

- increasing the extent to which disabled pupils can participate in the curriculum;
- improving the physical environment of schools to enable disabled pupils to take better advantage of education, benefits, facilities, and services provided; and
- improving the availability of accessible information to disabled pupils.

With this in mind, our accessibility plan has been drawn up and covers three years. However, this is a continuing plan, and will be reviewed at any point, should there be the need to adjust or respond to the specific needs of any individual within our school.

We are committed to providing a fully-accessible environment that values and includes all pupils, staff, parents, and visitors regardless of their age, education, physical, sensory, social, spiritual, emotional, and cultural needs.

We are committed to challenging negative attitudes about disability and accessibility, and to developing a culture of awareness, tolerance, and inclusion.
